- Children from class 1 to class 10 will be eligible for this competition. They will be categorized as follows: (1st -3rd) Sub-Junior, (4th – 6th) Junior, (7th – 10th Std) Senior group.
- Selected children from the preliminary round will compete in the finals.
- The preliminary round of the chess competition will be conducted at the school premises and toppers from each class will qualify for the final round (inter-school competition) to be held at a predetermined venue.
- Each player must make all of his moves in the five minutes allotted on his/her clock. Time delay features are not entertained.
- Organizers will provide the chess board & pawns.
- Each participant should pay a sum of Rs. 200/- as registration fee for taking part in the competition which is a one time fee.
- Participation certificate will be provided to each participant. Schools supporting the cause will be felicitated in the award ceremony.
- **TOP 3 best chess players under Sub-Junior, junior & Senior groups will be awarded as follows:**
 - ONE 1st PRIZE winner will get gift worth Rs. 2000/- & a trophy + certificate
 - ONE 2nd PRIZE winner will get gift worth Rs.1000/- & a trophy + certificate
 - ONE 3rd PRIZE winner will get gift worth Rs.500/- & a trophy + certificate
 - 12 Consolation Prizes in each category will be awarded with a trophy + certificate
- **The top 3 winners of the preliminary round in each category will be rewarded with the School Champion Trophy & Certificate.**
- Schools supporting this competition shall be recognized with a memento at the award ceremony.
- No spot registrations will be entertained. Participants shall enroll through their respective school.
- Any claims or disputes to be addressed to the arbiter at the venue and the arbiter's decision on the qualifiers will be final and binding.
- The Organizer reserves the right to reject entries at any point of time during the tournament in case of mis-conduct.
- Any dispute shall be clarified with the Arbiter prior to the succeeding round of the tournament.
- Arbiter's decision is final and binding.
